Regular Membership is for those individuals that are interested in attending monthly meetings, serving on committees or the Board and, in general, participating in the club's operation. Regular membership is open to individuals 18 years or older, and annual dues are \$15.00 per year.

Family Membership is for a husband and wife, each of whom would be entitled to a separate vote at meetings. Annual dues for family memberships are \$20.00 per year.

Associate Membership is for those individuals who support the purposes of the club but cannot normally attend monthly meetings and actively participate in the club's operation. Associate members have all rights and privileges of the club except they cannot vote or hold office. Annual dues for associate memberships are \$15.00 per year.
